RESOLUTION 96-2

WHEREAS:

All privately owned property within the Legend Lake residential community is governed by the original covenants which were written in the 1960's, and

WHEREAS:

Said covenants were designed to specifically control land use and protect both land and water quality, and

WHEREAS:

Covenant No. 8's reference to erecting and maintaining of an outside toilet or privy may well have been intended to prevent land and water pollution since approved self-contained temporary toilets were not yet in existence, and

WHEREAS:

Both state and federal law mandates such approved units be made available during time of construction activity, and

WHEREAS:

From time to time, certain situations arise whereby allowing the use of such approved temporary units will better serve that protection of both land and water quality than do current practices used in its stead.

THEREFORE, BE IT RESOLVED:

That the LLPOA Camping Committee be granted the authority to issue permits which will allow the placement of one chemical, self-contained, approved temporary toilet on a specific lot, for a period of usage not to exceed 72 hours. Unit may not be delivered more than 24 hours prior to usage period and must be removed with 48 hours after usage period.

BE IT FURTHER RESOLVED:

Such permission can only be obtained by the owners completing and filing the attached "Application For Use of Temporary Toilet", which shall be an integral part of this resolution, a minimum of 10 days prior to intended delivery of said unit, only after Camping Committee approval and receipt of a \$ 100.00 compliance deposit. Compliance deposit will be fully refunded if all stipulations and conditions are adhered to.
